The **CREF/AEPC** invites **Electronic Bids** from eligible Bidders for the procurement of Goods "**Supply, Delivery, Installation, Testing and Commissioning of Electrical Components of Dhaulapani & Niyapani Micro Hydropower Operated Lift Irrigation System in Jumla District, Bane Gaun & Kalapani Jhalgaun Micro Hydropower Operated Lift Irrigation System in Bajura District & Tinkopre Grid Operated Multi Stage Lift Irrigation System in Sindhuli District**" under National Competitive Bidding - Single Stage Two Envelope bidding procedures. Bidding is open to all Eligible and Qualified Bidders as mentioned in the Bidding Document.
2. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate bids, one containing (i) the Technical Bid and the other (ii) the Price Bid as per the provision of ITB 23 of the Bidding Document.
3. Eligible Bidders may obtain further information and inspect the Bidding Document at the office of **CREF/AEPC** or may visit e-GP system of PPMO: **www.bolpatra.gov.np/egp**.
4. Complete set of Bidding Document for the task in English is available online and may be downloaded for e-submission from the e-GP system of PPMO: **www.bolpatra.gov.np/egp**. Bidders, submitting their bid electronically, should deposit the cost of Bidding Document (non-refundable fee) of **NRs. 3,000.00** to the **AEPC/CREF/RERL-Technical Assistance Account Number: 0010037403500010, NMB Bank Babarmahal, Kathmandu, Nepal** and scanned copy in PDF format of the voucher/receipt of the deposited amount must be submitted/uploaded along with the Electronic Bid.
5. Pre-bid meeting shall be held at the office of **CREF/AEPC** at **11.00 A.M. on 19 March 2024**.
6. Interested Bidders are required to submit the Electronic Bids through e-GP system of PPMO: **www.bolpatra.gov.np/egp** to the office of **AEPC/RERL** on or before **1:00 P.M. on 2 April 2024**.
7. Submitted Electronic Bids (Technical) will be opened in the presence of Bidders' representatives who choose to attend at **1:15 P.M. on 2 April 2024** at the office of **CREF/AEPC, Thapagaun, Baneshwor, Kathmandu, Nepal**.
8. Bids must be valid for a period of 90 days counting from the date of bid opening and must be accompanied by scanned copy of the bid security in pdf format, amounting to a minimum NRs. 310,000.00, which shall be valid for minimum 30 days beyond the bid validity period (i.e., Valid up to minimum 30 July 2024).
