



Invitation for Electronic Bids

1. Alternative Energy Promotion Centre (AEPIC) invites **Electronic Bids** from eligible and qualified bidders for the **Procurement of Works “Construction of Chyagi Khola MHP, 20 kW, Sarkegad Rural Municipality Ward No. 6, Humla”** under **National Competitive Bidding (NCB)–Single Stage Two Envelope** Bidding procedures as specified in prevailing Public Procurement Act and Public Procurement Regulations of Nepal. Bidding is open to all eligible and qualified national bidders as per Section V of bidding document. Only eligible bidders with the following key qualifications should participate in this bidding:
 - Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **NRs. 20 Million**
 - Minimum Work experience of similar size and nature: One (1) Contract with a value of at least **NRs 8.5 Million**
2. Under the **Single Stage, Two Envelope Procedure**, Bidders are required to submit **(i) the Technical Bid** and the other **(ii) the Price Bid**, as per the provision of ITB 21 of the Bidding Document.

5. **Pre-Bid Meeting** shall be held at **AEPIC, Tahachal, Kathmandu** at **11:00 A.M. on 4 April 2025**.
6. Interested Eligible and Qualified Bidders are required to submit the Electronic Bids through e-GP system of PPMO **www.bolpatra.gov.np/egp** on or before **12:00 Noon on 18 April 2025**.
7. Submitted Electronic Bids will be opened in presence of Bidders' representatives who choose to attend at **12:15 P.M. on 18 April 2025** at the office of **AEPIC, Tahachal, Kathmandu, Nepal**.
8. Bids must be valid for a period of **90 days** from the date of Technical Bid opening and must be accompanied by a bid security or scanned copy of the bid security in PDF format amounting to a minimum of **NRs. 550,000**, which shall be valid for 30 days beyond the validity period of the bid (**i.e., Valid up to a minimum of 15 August 2025**).

If bidder wishes to submit the Bid Security in the form of cash, the cash should be deposited in Office Code: **3080002** and Account Name: **DTCO, Kathmandu**, Bank Account No.: **1201200001002524** at Nepal Rastra Bank, Thapathali and submit/upload the receipt of the deposited amount of cash along with the eBid.
