- 8. Submitted eBids will be opened in presence of Bidders' representatives who choose to attend on the **date and time mentioned** in the table above at the office of AEPC, Tahachal, Kathmandu, Nepal.

Bids must be valid for a period of 120 days counting from the date of Technical Bid opening and must be accompanied by scanned copy of the Bid Security in PDF format, amounting to a minimum amount, **as mentioned in the table above**, which shall be valid for minimum 30 days beyond the bid validity period (i.e., Valid up to minimum **15 July 2025**).
