3. Complete set of Bidding Document in English may be purchased from the office of AEPC/NRREP, Khumaltar Height, Lalitpur, Nepal during office hours on all working days by eligible Bidders **21 May 2018** onwards on the submission of a **Written Application**, copies of **Company/Firm Registration** and **VAT Registration** certificates and upon payment of a non-refundable fee of **NRs. 5,000.00 for SN 1 (Mada Khola MHP)** and **NRs. 3,000.00 for SN 2 (Rota Naumuli MHP)**. The Bid document shall be available for sale up to office hours till **19 June 2018**.
4. Pre-bid meeting shall be held at AEPC, Khumaltar Height, Lalitpur, Nepal at **11:00 A.M. on 5 June 2018**.
5. Sealed bid must be submitted to the office of AEPC/NRREP, Khumaltar Height, Lalitpur, Nepal by hand/courier on or before **12:00 Noon on 20 June 2018**. Bids received after this deadline will not be accepted.
6. Bid must be valid for a period of **90 days**, counting from the day of bid opening and must be accompanied by bid security, amounting to minimum as specified in above table, which shall be valid for minimum **30 days** beyond the bid validity period (i.e., **Valid up to minimum 17 October 2018**).
7. If bidder wishes to submit the bid security in the form of Cash, the cash should be deposited in AEPC's Office Code 28-331-01 and Account Name DTCO, Lalitpur, Bank Account No. 16856 KHA 3 at Nepal Bank Ltd., Gabahal, Lalitpur Branch and submit the original receipt of the deposited amount of cash along with the sealed Bid.
8. Received sealed Bids shall be opened in the presence of Bidders' representatives who choose to attend at as specified in above table at the office of AEPC/NRREP, Khumaltar Height, Lalitpur, Nepal. But nothing shall bar the opening of Bid by the reason only that any bidder or its agent is not present. Bidder's representative should bear with authorization duly signed by the authority of firm at the time of Bid opening.
9. If the last date of purchasing, submission and opening of bids falls on a government/public holiday then the next working day shall be considered the last day. In such case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
10. AEPC/NRREP and User committee shall not be responsible for any costs or expenses incurred by bidders in connection with the preparation or submission of Bids. **The bidders are advised to visit and assess the actual site conditions before submitting their bid.**
11. AEPC/NRREP and User Committee reserves the right to accept or reject, wholly or partly any or all the Bids without assigning any reason, whatsoever.
