Invitation for Bids

For “Supply, Delivery, Installation, Testing & Commissioning of Electro-Mechanical Equipment of Chip Khola Micro Hydro Project (40 kW, 451 HH)” at Sisne Gaunpalika, Ward No. 2, (Previous Pwang VDC Ward No. 1), Rukum District

1. **On behalf of Chip Khola Micro Hydro Project Users Committee (CKMHPUC), AEPC/NRREP** invites sealed bids from the registered eligible and qualified Suppliers/Bidders under National Competitive Bidding (NCB) for the **Supply, Delivery, Installation, Testing & Commissioning of Electro-Mechanical Equipment of Chip Khola Micro Hydro Project (40 kW, 451HH)** as per the required specifications mentioned. Bidding is open to all eligible and qualified Bidders.
2. Interested eligible Bidders may obtain further information and inspect the bidding document in English at the office of AEPC/NRREP, Khumaltar Height, Lalitpur, Nepal during office hours.
3. Complete set of Bidding Document in English may be purchased from the office of AEPC/NRREP, Khumaltar Height, Lalitpur, Nepal during office hours on all working days by eligible Bidders **23 April 2018** onwards on the submission of a **Written Application**, copies of **Company/Firm Registration** and **VAT Registration** certificates and upon payment of a non-refundable fee of **NRs. 3,000.00**. The Bid document shall be available for sale up to office hours till **22 May 2018**.
4. Pre-bid meeting shall be held at AEPC, Khumaltar Height, Lalitpur, Nepal at **11:00 A.M. on 8 May 2018**.
5. Sealed bids must be submitted to the office of AEPC/NRREP, Khumaltar Height, Lalitpur, Nepal by hand/courier on or before **12:00 Noon on 23 May 2018**. Documents received after this deadline shall not be accepted.
6. Bids must be valid for a period of **90** days, counting from the day of bid opening and must be accompanied by bid security, amounting to minimum **NRs. 400,000.00 (In Words: Four Hundred Thousand Rupees Only)**, which shall be valid for minimum 30 days beyond the bid validity period (i.e. **Valid up to minimum 19 September 2018**).
7. If bidder wishes to submit the Bid Security in the form of cash, the cash should be deposited in AEPC's Office Code **28-331-01** and Account Name DTCO, Lalitpur, Bank Account No. **16856 KHA 3 at Nepal Bank Ltd.**, Gabahal, Lalitpur Branch and submit the original receipt of the deposited amount of cash along with the sealed Bid.
8. Received Sealed Bids shall be opened in the presence of Bidders' representatives who choose to attend at **12:30 P.M. on 23 May 2018** at the office of AEPC, Khumaltar Height, Lalitpur, Nepal. But nothing shall bar the opening of Bid by the reason only that any bidder or its agent is not present. Bidder's representative should come with authorization duly signed by the authority of firm at the time of bid opening.
9. If the last date of purchasing, submission and opening falls on a government/public holiday then the next working day shall be considered the last day. In such case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
10. AEPC/NRREP/CKMHPUC shall not be responsible for any costs or expenses incurred by bidders in connection with the preparation or submission of Bids. The bidders are advised to visit and assess the actual site conditions before submitting their bid.
11. AEPC/NRREP/CKMHPUC reserves the right to accept or reject, wholly or partly any or all the Bids without assigning any reason, whatsoever.
