Received Sealed Quotations and Sealed Bids shall be opened in the presence of Bidders' representatives who choose to attend at as mentioned in the table above at the office of AEPC, Khumaltar Height, Lalitpur, Nepal. But nothing shall bar the opening of SQ/Tender by the reason only that any bidder or its agent is not present. Bidder's representative should bear with authorization duly signed by the authority of firm at the time of bid opening.
 5. If bidder wishes to submit the bid security in the form of Cash, the cash should be deposited in AEPC's Office Code 28-331-01 and Account Name DTCCO, Lalitpur, Bank Account No. 16856 KHA 3 at Nepal Bank Ltd., Gabahal, Lalitpur Branch and submit the original receipt of the deposited amount of cash along with the Sealed Quotation or/and Sealed Bid.
 6. If the last date of purchasing and/or submission falls on a government holiday, then the next working day same time shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of SQ/Bid submission.
 7. Bidders are advised to visit site and assess the actual site conditions before submitting their bid. AEPC and User Committee shall not be responsible for any costs or expenses incurred by bidders in connection with preparation or submission of Bids.
 8. AEPC and User Committee reserve the right to accept or reject, wholly or partly any or all the bids without assigning any reason, whatsoever.
