6. Submitted SQs will be opened in the presence of Bidder's representatives who choose to attend at **21:30 P.M. on 2 January 2024** at the office of **AEPC, Tahachal, Kathmandu**.

Sealed Quotation must be valid for a period of 45 days counting from the date of SQ opening and must be accompanied by SQ/Bid security a minimum of **NRs. 42,000.00** which shall be valid for a minimum of 30 days beyond the quotation validity period (i.e., **Valid up to a minimum of 17 March 2025**).
