## **Invitation for Electronic Bids**

- 1. Alternative Energy Promotion Centre (AEPC) invites **Electronic Bids** from eligible and qualified bidders for the **Procurement of Works** "Rehabilitation of Micro Hydro Projects Located in Achham, Doti, Humla, Bajhang, Baitadi, and Jumla District" under National Competitive Bidding (NCB)—Single Stage Two Envelope Bidding procedures as specified in prevailing Public Procurement Act and Public Procurement Regulations of Nepal. Bidding is open to all eligible and qualified national bidders as per Section V of bidding document. Only eligible bidders with the following key qualifications should participate in this bidding:
  - Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: NRs. 27 Million
  - Minimum Work experience of similar size and nature: One (1) Contract with a value of at least NRs 11 Million
- 2. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit (i) the Technical Bid and the other (ii) the Price Bid, as per the provision of ITB 21 of the Bidding Document.

- 5. Pre-Bid Meeting shall be held at AEPC, Tahachal, Kathmandu at 11:00 A.M. on 2 March 2025.
- Interested Eligible and Qualified Bidders are required to submit the Electronic Bids through e-GP system of PPMO www.bolpatra.gov.np/egp on or before 12:00 Noon on 14 March 2025.
- 7. Submitted Electronic Bids will be opened in presence of Bidders' representatives who choose to attend at 12:15 P.M. on 14 March 2025 at the office of AEPC, Tahachal, Kathmandu, Nepal.
- 8. Bids must be valid for a period of **90 days** from the date of Technical Bid opening and must be accompanied by a bid security or scanned copy of the bid security in PDF format amounting to a minimum of **NRs. 700,000**, which shall be valid for 30 days beyond the validity period of the bid (i.e., Valid up to a minimum of 11 July 2025).

If bidder wishes to submit the Bid Security in the form of cash, the cash should be deposited in Office Code: 3080002 and Account Name: DTCO, Kathmandu, Bank Account No.: 1201200001002524 at Nepal Rastra Bank, Thapathali and submit/upload the receipt of the deposited amount of cash along with the eBid.
