- 1. Alternative Energy Promotion Centre (AEPC) has received funds from the Government of Nepal (GoN) towards the cost of the **Construction of the Micro Hydro Project at the following locations** and intends to apply part of the funds to cover eligible payments under the Contract. Bidding is open to all eligible bidders as per Section V of the bidding document.
- 2. The AEPC invites **Electronic Bids** from eligible and qualified bidders for the **Procurement of Works** "Construction of Micro Hydro Projects" at sites mentioned in the table below under National Competitive Bidding (NCB) –Single Stage Two Envelope Bidding procedures as specified in prevailing Public Procurement Act and Public Procurement Regulations of Nepal.

Under the **Single Stage, Two Envelope Procedure**, Bidders are required to submit simultaneously **two separate sealed envelopes**, one containing (i) the **Technical Bid** and the other (ii) the **Price Bid**, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.

- 6. **Pre-Bid Meeting** shall be held at **AEPC**, **Mid-Baneshwor**, **Kathmandu** at **11:00 A.M.** onwards **on 23 February 2024**, 30-minute intervals for each task respectively.
- 7. Interested Eligible and Qualified Bidders are required to submit the Electronic Bids through e-GP system of PPMO: www.bolpatra.gov.np/egp on or before 12:00 Noon on 7 March 2024.
- 8. Submitted Electronic Bids will be opened in the presence of Bidders' representatives who choose to attend at the date and time mentioned in the table above at the office of AEPC, Mid-Baneshwor, Kathmandu, Nepal.
- 9. Bids must be valid for a period of 90 days counting from the day of bid opening and must be accompanied by a scanned copy of the bid security in PDF format, amounting to a minimum amount mentioned in the table above which shall be valid for a minimum of 30 days beyond the bid validity period (i.e., Valid up to minimum of 4 July 2024).
