- The proposal must contain **Technical** and **Financial** proposals sealed in **Separate Envelopes**. Both the sealed proposals must be sealed in another single envelop mentioning **Title** of the task and **RFP Number**.

- Proposal (in Hard Copy) must be delivered manually to the address above by **12:00 hour's** local time on or before **07 March 2019**.
- Received Proposal (**Technical**) shall be opened in the presence of Proponents' representatives who choose to attend at **12.30 PM** on **07 March 2019** at the office of AEPC, Khumaltar Height, Lalitpur, Nepal. But nothing shall bar the opening of Technical Proposal by the reason only that any proponent or its agent is not present. Proponents' representative should bear with authorization duly signed by the authority of firm at the time of Technical Proposal opening.
- The method of selection will be Quality and Cost Based Selection (QCBS), 90:10 weightage for Technical and Financial proposals respectively.
- Proposals must be valid for a period of 90 days, counting from the day of Technical Proposal opening.
- Professional Liability Insurance of 100% Contract Value should be submitted within 30 days from the date of agreement by the selected Consulting Firm.
- If deadline for submission and opening falls in public holiday, the deadline will be same time of the immediate next working day.
- AEPC reserves the right to accept or reject, wholly or partly any or all the proposals without assigning any reason, whatsoever.

Section 2. Instructions to Consultants and Data Sheet

A. General Provisions

1. Definitions

- (a). "Affiliate(s)" means an individual or an entity that directly or indirectly controls, is controlled by, or is under common control with the Consultant.
- (b). "Applicable Guidelines" means the policies of the Development Partner (DP) governing the selection and Contract award process, in case of DP funded project. "Applicable Law" means the laws and any other instruments having the force of law in Nepal as they may be issued and in force from time to time.
- (c). "Borrower [or Recipient or Beneficiary]" means the Government, Government agency or other entity that signs the financing [or loan/credit/grant/project] agreement with the Development Partner.
- (d). "Client" means the [procuring entity/implementing/ executing agency] that signs the Contract for the Services with the selected Consultant.
- (e). "Consultant" means a legally-established professional consulting firm or an entity that may provide or provides the Services to the Client under the Contract.
- (f). "Contract" means a legally binding written agreement signed between the Client and the Consultant and includes all the attached documents listed in its Clause 1 (the General Conditions of Contract (GCC), the Special Conditions of Contract (SCC), and the Appendices).
- (g). "Data Sheet" means an integral part of the Instructions to Consultants (ITC) Section 2 that is used to reflect specific assignment conditions to supplement, but not to over-write, the provisions of the ITC.
- (h). "Day" means a calendar day.
- (i). "Development Partner (DP)" means the country/institution funding the project as specified in the Data Sheet.
- (j). "Experts" means, collectively, Key Experts, Non-Key Experts, or any other personnel of the Consultant, Sub-consultant or Joint Venture member(s).
- (k). "Government" means the government of the Nepal.
- (l). "Joint Venture (JV)" means an association with or without a legal personality distinct from that of its members, of more than one Consultant where one member has the authority to conduct all business for and on behalf of any and all the members of the JV, and where the members of the JV are jointly and severally liable to the Client for the performance of the Contract.
- (m). "Key Expert(s)" means an individual professional whose skills, qualifications, knowledge and experience are critical to the performance of the Services under the Contract and whose CV is taken into account in the technical evaluation of the Consultant's proposal.
- (n). "ITC" (this Section 2 of the RFP) means the Instructions to Consultants that provides the shortlisted Consultants with all information needed to prepare their Proposals.
- (o). "LOI" (Section 1 of the RFP) means the Letter of Invitation being sent by the Client to the shortlisted Consultants.
- (p). "Non-Key Expert(s)" means an individual professional provided by the Consultant or its Sub-consultant and who is assigned to perform the Services or any part thereof under the Contract and

	whose CVs are not evaluated individually. (q). "Proposal" means the Technical Proposal and the Financial
	Proposal of the Consultant.
	(r). "RFP" means the Request for Proposals prepared by the Client for the selection of Consultants, based on the SRFP.
	(s). "SRFP" means the Standard Request for Proposals issued by PPMO, which must be used by the Public Entity as the basis for the preparation of the RFP.
	(t). "Services" means the work to be performed by the Consultant pursuant to the Contract.
	(u). "Sub-consultant" means an entity to whom the Consultant intends to subcontract any part of the Services while remaining responsible to the Client during the performance of the Contract.
	(v). "TORs" (this Section 7 of the RFP) means the Terms of Reference that explain the objectives, scope of work, activities, and tasks to be performed, respective responsibilities of the Client and the Consultant, and expected results and deliverables of the assignment.
2. Introduction	2.1The Client named in the Data Sheet intends to select a Consultant from those listed in the Letter of Invitation, in accordance with the method of selection specified in the Data Sheet .
	2.2 The shortlisted Consultants are invited to submit a Technical Proposal and a Financial Proposal, or a Technical Proposal only, as specified in the Data Sheet , for consulting services required for the assignment named in the Data Sheet . The Proposal will be the basis for negotiating and ultimately signing the Contract with the selected Consultant.
	2.3 The Consultants should familiarize themselves with the local conditions and take them into account in preparing their Proposals, including attending a pre-proposal conference if one is specified in the Data Sheet . Attending any such pre-proposal conference is optional and is at the Consultants' expense.
	2.4 The Client will timely provide, at no cost to the Consultants, the inputs, relevant project data, and reports required for the preparation of the Consultant's Proposal as specified in the Data Sheet .
3. Conflict of Interest	3.1 The Consultant is required to provide professional, objective, and impartial advice, at all times holding the Client's interests paramount, strictly avoiding conflicts with other assignments or its own corporate interests, and acting without any consideration for future work.
	The Consultant has an obligation to disclose to the Client any situation of actual or potential conflict that impacts its capacity to serve the best interest of its Client. Failure to disclose such situations may lead to the disqualification of the Consultant or the termination of its Contract and/or blacklisting by the Public Procurement Monitoring Office/DP.
	Without limitation on the generality of the foregoing, and unless stated otherwise in the Data Sheet , the Consultant shall not be hired under the circumstances set forth below:
a. Conflicting activities	(i) Conflict between consulting activities and procurement of goods, works or non-consulting services: a firm that has been engaged by the Client to provide goods, works, or non-consulting services for a project, or any of its Affiliates, shall be disqualified from providing consulting services resulting from or directly related to those goods, works, or non-consulting services. Conversely, a firm hired to

		provide consulting services for the preparation or implementation of a project, or any of its Affiliates, shall be disqualified from subsequently providing goods or works or non-consulting services resulting from or directly related to the consulting services for such preparation or implementation.
b.	Conflicting assignments	(ii) <u>Conflict among consulting assignments:</u> a Consultant (including its Experts and Sub-consultants) or any of its Affiliates shall not be hired for any assignment that, by its nature, may be in conflict with another assignment of the Consultant for the same or for another Client.
c.	Conflicting relationships	(iii) Relationship with the Client's staff: a Consultant (including its Experts and Sub-consultants) that has a close business or family relationship with a professional staff of the Client or are directly or indirectly involved in any part of (i) the preparation of the Terms of Reference for the assignment, (ii) the selection process for the Contract, or (iii) the supervision of the Contract, may not be awarded a Contract.
4.	Unfair Competitive Advantage	4.1 Fairness and transparency in the selection process require that the Consultants or their Affiliates competing for a specific assignment do not derive a competitive advantage from having provided consulting services related to the assignment in question. To that end, the Client shall indicate in the Data Sheet and make available to all shortlisted Consultants together with this RFP all information that would in that respect give such Consultant any unfair competitive advantage over competing Consultants.
5.	Corrupt and Fraudulent Practices	 5.1 The GoN/DPrequires compliance with its policy in regard to corrupt and fraudulent/prohibited practices as set forth in Section 6. 5.2 In further pursuance of this policy, Consultant shall permit and shall cause its sub-consultants and sub-contractors to permit GoN/DP or its representatives to inspect the accounts, records and other documents relating to the submission of the Proposal and execution of the contract, in case of award, and to have the accounts and records audited by auditors appointed by the GoN/DP. 5.3Consultants shall be aware of the provisions on fraud and corruption stated in Clause GCC 10.1.
6.	Eligibility	 6.1 The GoN/DP permits consultants (individuals and firms, including Joint Ventures and their individual members) from the eligible countries as stated in Section 5 to offer consulting services for GoN/DP-financed projects. 6.2 Furthermore, it is the Consultant's responsibility to ensure that its Experts, joint venture members, Sub-consultants, agents (declared or not), sub-contractors, service providers, suppliers and/or their employees meet the eligibility requirements as established by the GoN/DP.Maximum number of partners in JV shall be Specified in Data sheet.
		6.3 As an exception to the foregoing Clauses 6.1 and 6.2 above:
a. S	Sanctions	6.3.1 A firm or an individual sanctioned by the GoN/DP in accordance with the above Clause 5.1 shall be ineligible to be awarded a GoN/DP-financed contract, or to benefit from a GoN/DP-financed contract, financially or otherwise, during such period of time as the GoN/DP shall determine. The list of debarred firms and individuals is available at the electronic address specified in the Data Sheet .

	B. Preparation of Proposals
7. General Considerations	7.1In preparing the Proposal, the Consultant is expected to examine the RFP in detail. Material deficiencies in providing the information requested in the RFP may result in rejection of the Proposal.
8. Cost of Preparation of Proposal	8.1The Consultant shall bear all costs associated with the preparation and submission of its Proposal, and the Client shall not be responsible or liable for those costs, regardless of the conduct or outcome of the selection process. The Client is not bound to accept any proposal, and reserves the right to annul the selection process at any time prior to Contract award, without thereby incurring any liability to the Consultant.
9. Language	9.1The Proposal, as well as all correspondence and documents relating to the Proposal exchanged between the Consultant and the Client, shall be written in the English language.
10. Documents Comprising the Proposal	 10.1 The Proposal shall comprise the documents and forms listed in the Data Sheet. 10.2 The Consultant shall furnish information on commissions, gratuities and fees, if any, paid or to be paid to agents or any other party relating to this Proposal and, if awarded, Contract execution, as requested in the Financial Proposal submission form (Section 4).
11. Only One Proposal	11.1 The Consultant (including the individual members of any Joint Venture) shall submit only one Proposal, either in its own name or as part of a Joint Venture in another Proposal. If a Consultant, including any Joint Venture member, submits or participates in more than one proposal, all such proposals shall be disqualified and rejected. This does not, however, preclude a Sub-consultant, or the Consultant's staff from participating as Key Experts and Non-Key Experts in more than one Proposal when circumstances justify and if stated in the Data Sheet .
12. Proposal Validity	 12.1The Data Sheet indicates the period during which the Consultant's Proposal must remain valid after the Proposal submission deadline. 12.2During this period, the Consultant shall maintain its original Proposal without any change, including the availability of the Key Experts, the proposed rates and the total price. 12.3If it is established that any Key Expert nominated in the Consultant's Proposal was not available at the time of Proposal submission or was included in the Proposal without his/her confirmation, such Proposal shall be disqualified and rejected for further evaluation, and may be subject to blacklisting in accordance with Clause 5 of this ITC.



 12.4The Client will make its best effort to complete the negotiations within the proposal's validity period. However, should the need arise, the Client may request, in writing, all Consultants who submitted Proposals prior to the submission deadline to extend the Proposals' validity. 12.5If the Consultant agrees to extend the validity of its Proposal, it shall be done without any change in the original Proposal and with the confirmation of the availability of the Key Experts. 12.6The Consultant has the right to refuse to extend the validity of its Proposal in which case such Proposal will not be further evaluated. 	
 12.7If any of the Key Experts become unavailable for the extended validity period, the Consultant shall provide a written adequate justification and evidence satisfactory to the Client together with the substitution request. In such case, a replacement Key Expert shall have equal or better qualifications and experience than those of the originally proposed Key Expert. The technical evaluation score, however, will remain to be based on the evaluation of the CV of the original Key Expert. 12.8 If the Consultant fails to provide a replacement Key Expert with equal or better qualifications, or if the provided reasons for the replacement or justification are unacceptable to the Client, such Proposal will be rejected. 	
12.9The Consultant shall not subcontract the whole of the Services unless otherwise indicated in the Data Sheet .	
 13.1The Consultant may request a clarification of any part of the RFP during the period indicated in the Data Sheet before the Proposals' submission deadline. Any request for clarification must be sent in writing, or by standard electronic means, to the Client's address indicated in the Data Sheet. The Client will respond in writing, or by standard electronic means, and will send written copies of the response (including an explanation of the query but without identifying its source) to all shortlisted Consultants. Should the Client deem it necessary to amend the RFP as a result of a clarification, it shall do so following the procedure described below: 13.1.1 At any time before the proposal submission deadline, the Client may amend the RFP by issuing an amendment in writing or by standard electronic means. The amendment shall be sent to all shortlisted Consultants and will be binding on them. The shortlisted Consultants shall acknowledge receipt of all amendments in writing. 13.1.2 If the amendment is substantial, the Client may extend the proposal submission deadline to give the shortlisted Consultants reasonable time to take an amendment into account in their Proposals. 13.1.3 The Consultant may submit a modified Proposal or a modification to any part of it at any time prior to the proposal submission deadline. No modifications to the Technical or Financial Proposal shall be accepted after the deadline. 	
 14.1 While preparing the Proposal, the Consultant must give particular attention to the following: 14.1.1 If a shortlisted Consultant considers that it may enhance its expertise for the assignment by associating with other consultants in the form of a Joint Venture or as Sub-consultants, it may do so with either (a) non-shortlisted Consultant(s), or (b) shortlisted

	Consultants if permitted in the Data Sheet . In all such cases a shortlisted Consultant must obtain the written approval of the Client prior to the submission of the Proposal. When associating with non-shortlisted firms in the form of a joint venture or a subconsultancy, the shortlisted Consultant shall be a lead member.	
	14.1.2 The Client may indicate in the Data Sheet the estimated Key Experts' time input (expressed in person-month) or the Client's estimated total cost of the assignment. This estimate is indicative and the Proposal shall be based on the Consultant's own estimates for the same.	
	14.1.3 If stated in the Data Sheet , the Consultant shall include in its Proposal at least the same time input (in the same unit as indicated in the Data Sheet) of Key Experts, failing which the Financial Proposal will be adjusted for the purpose of comparison of proposals and decision for award in accordance with the procedure in the Data Sheet .	
	14.1.4 For assignments under the Fixed-Budget selection method, the estimated Key Experts' time input is not disclosed. Total available budget, with an indication whether it is inclusive or exclusive of taxes, is given in the Data Sheet , and the Financial Proposal shall not exceed this budget.	
15. Technical Proposal Format and Content	15.1 The Technical Proposal shall not include any financial information. A Technical Proposal containing material financial information shall be declared non-responsive.	
	15.2Only one curriculum vitae (CV) may be submitted for each key expert. If a technical proposal nominates more than one expert for a position, the Client will evaluate all CVs and apply the lowest score for the position.	
16. Financial Proposal	16.1The Financial Proposal shall be prepared using the Standard Forms provided in Section 4 of the RFP. It shall list all costs associated with the assignment, including (a) remuneration for Key Experts and Non-Key Experts, (b) other expenses, (c) provisional sums when applicable indicated in the Data Sheet .	
a. Price Adjustment	16.2 For assignments with a duration exceeding 12 months, a price adjustment provision for foreign and/or local inflation for remuneration rates applies if so stated in the Data Sheet .	
b. Taxes	16.3The Consultant and its Sub-consultants and Experts are responsible for meeting all tax liabilities arising out of the Contract. Information on taxes in the Client's country is provided in the Data Sheet .	
c. Currency of Proposal	16.4The Consultant may express the price for its Services in the currency or currencies as stated in the Data Sheet . If indicated in the Data Sheet , the portion of the price representing local cost shall be stated in the Nepalese Rupees.	
d. Currency of Payment	16.5 Payment under the Contract shall be made in the currency or currencies in which the payment is requested in the Proposal.	
	C. Submission, Opening and Evaluation	
17. Submission, Sealing, and Marking of Proposals	17.1 The Consultant shall submit a signed and complete Proposal comprising the documents and forms in accordance with Clause 10 (Documents Comprising Proposal). The submission can be done by mail or by hand. If specified in the Data Sheet , the Consultant has the option of submitting its Proposals electronically.	



- 17.2 An authorized representative of the Consultant shall sign the original submission letters in the required format for both the Technical Proposal and, if applicable, the Financial Proposals and shall initial all pages of both. The authorization shall be in the form of a written power of attorney attached to the Technical Proposal.
- 17.3 A Proposal submitted by a Joint Venture shall be signed by all members so as to be legally binding on all members, or by an authorized representative who has a written power of attorney signed by each member's authorized representative.
- 17.4 Any modifications, revisions, interlineations, erasures, or overwriting shall be valid only if they are signed or initialed by the person signing the Proposal.
- 17.5 The signed Proposal shall be marked "ORIGINAL", and its copies marked "COPY" as appropriate. The number of copies is indicated in the **Data Sheet**. All copies shall be made from the signed original. If there are discrepancies between the original and the copies, the original shall prevail.
- 17.6 The original and all the copies of the Technical Proposal shall be placed inside of a sealed envelope clearly marked "TECHNICAL PROPOSAL", "[Name of the Assignment]", reference number, name and address of the Consultant, and with a warning "DO NOT OPEN UNTIL [INSERT THE DATE AND THE TIME OF THE TECHNICAL PROPOSAL SUBMISSION DEADLINE]."
- 17.7 Similarly, the original Financial Proposal (if required for the applicable selection method) shall be placed inside of a sealed envelope clearly marked "FINANCIAL PROPOSAL" followed by the name of the assignment, reference number, name and address of the Consultant, and with a warning "DO NOT OPEN WITH THE TECHNICAL PROPOSAL."
- 17.8 The sealed envelopes containing the Technical and Financial Proposals shall be placed into one outer envelope and sealed. This outer envelope shall bear the submission address, RFP reference number, the name of the assignment, Consultant's name and the address, and shall be clearly marked "DO NOT OPEN BEFORE[insert the time and date of the submission deadline indicated in the Data Sheet]".
- 17.9 If the envelopes and packages with the Proposal are not sealed and marked as required, the Client will assume no responsibility for the misplacement, loss, or premature opening of the Proposal. For QCBS, FBS and LCS, if the Technical and Financial Proposals are not submitted in separate sealed envelopes as required, the Client shall reject the Proposal.



 - (aa)deliberately destroying, falsifying, altering or concealing of evidence material to the investigation or making false statements to investigators in order to materially impede a GoN/DP investigation into allegations of a corrupt, fraudulent, coercive or collusive practice; and/or threatening, harassing or intimidating any party to prevent it from disclosing its knowledge of matters relevant to the investigation or from pursuing the investigation; or
 - (bb) acts intended to materially impede the exercise of the GoN's/DP's inspection and audit rights provided for under Clause GCC 25.2.
- b. will reject a proposal for award if it determines that the consultant recommended for award has engaged in corrupt or fraudulent activities in competing for the contract in question;

The Government of Nepal (GoN) and External Development Partners were supporting Nepal's rural and renewable energy sector have designed National Rural and Renewable Energy Programme (NRREP) which was implemented between the period 2012-2017. AEPC has been taking on with the responsibility on continuation of programme implementation for current and upcoming years starting from mid-July 2017 to onwards. The Biogas Sub-component of AEPC, along with the household biogas plants dwells upon the promotion of community, commercial, institutional biogas plants and municipal scale waste to energy plants. The annual targets of AEPC for different biogas plants are usually 26,000 Household, 240 Community, Institutional Commercial and Municipal biogas plants. The actual target for current FY 2075/76 is 25000 domestic biogas, 100 community and institutional biogas and 150 commercial and municipal biogas (waste to energy) projects.

The target shown on domestic biogas above also tells that domestic biogas promotion is to remain in the programme as main stay. Hence there is a need to rise and scaling up the promotion and installation activities during the designated programme period and in this fiscal year. And for this additional numbers of trained masons are to be produced for the quality construction of large number of plants so as to meet the target set as mentioned above.

2. Background

In Nepal, biogas is emerging as a solution of clean energy at household level and especially in the rural parts. As per the user survey report, more than 95 percent users are satisfied with the performance of this technology. The performance of the biogas plants depend on the quality of installation/construction and quality standards of biogas appliances. AEPC has been promoting biogas technology all over the country under government subsidy provision and more than 130 private companies have been competent/recognized or in recognizing process for the biogas installation/construction purpose in this FY 2075/76. It is evident that well trained mason and supervisor play a pivotal role in the company for installation/constructing a quality biogas plant. The competent/recognized companies install/construct biogas plant only through trained mason and supervised by trained supervisor. Moreover the subsidy will be provided only to those plants installed/constructed by the trained and registered masons and supervised by trained supervisors.

It is obvious that the dropout rate of masons and supervisors yearly is around 30 % from the field of biogas sector additionally this dropout rate is increased due to earthquake affected area's need for re-building or new households and every year new trained masons and supervisors are required. Furthermore the newly competent/recognized companies need trained numbers of masons and supervisors to establish themselves and for which they shall be assisted given first priority. And hence within the budget limit for this year in the background of more than one hundred and thirty working companies at least 50 masons including women and disadvantage



group (DAG) are to be trained for competent/recognized companies for domestic biogas installation/construction so as to accelerate the construction of plants. Hence from this assignment, it has been expected to train 50 masons (biogas technician level-1) including women and DAG people as high preference.

3. Objectives of the Assignment

3.1 General Objectives

To build capacity on different level of skilled human resources for biogas sector and production of 50 Masons (Biogas Technician Level-1) including women and DAG group.

3.2 Specific Objectives

Conduction of biogas mason training for 50 participants for the production of biogas masons including women and DAG people at highest priority through cost sharing model (travel cost) from respective companies to produce 50 Masons (Biogas Technician Level-1) with theoretically and practically sound knowledge on biogas installation/construction and its technological and social aspects

4. Scope of Work (activities)

The scope of work shall include following, but shall not necessarily be limited to the following:

The existing training manual will provide the basis for providing the training. The scope of the assignment will be, but not limited to, followings-

- Relevant desk study.
- Review and assess the training manuals.
- Prepare a training schedule in consent with AEPC.
- Follow a complete set of training curriculum prepared by AEPC in consent with CTEVT
- 25 trainee will be participated in each training seasons or batch
- Work in close coordination with AEPC and NBPA for the finalized list of trainees.
- Conduction of biogas mason training for 50 participants so as to produce trained 50 masons (biogas technician level -1).
- Conduct a residential training (with complete good food and accommodation for the participants and trainers for the period of training at least 8 days for each batch)
- Make necessary arrangement for all the theoretical classes and practical sessions in new under construction domestic biogas plant with coordination with nearby biogas construction companies and biogas user.
- Finalization of appropriate trainers in consent with AEPC
- Prepare the report incorporating all the activities of the training sessions, achievements, feedback from trainees etc, and the drawbacks with suggested appropriate future strategies.
- Appropriate training venue or location to conduct the training in the respective location will be finalized in close coordination with AEPC based on the concentration of the biogas construction companies and their demand of mason. The Training Venue may be outside Kathmandu Valley.



5. Inputs from AEPC/NRREP

The assignment shall be conducted in a close coordination of Biogas Subcomponent (BSC).

There will be following inputs for completing the assignment-

- AEPCbudget and relevant training documents / materials and information.
- Input from relevant AEPC/SREP officials.

6. Time/duration

The training programme should be completed within two months (3 Months) from the date of signing the contract agreement and the reporting should be done within two weeks of the completion of the training. The date of the training will be jointly finalized with BSC and the Consulting Firms/Organizations.

7. Deliverables (output)

The Consulting Firms / Organizations will submit the following to the client in the timeline stipulated below:

- Inception report to be approved by AEPC
- Report on the completion of training for 50 masons 25 in each batch.
- Provide certificates to the successful trainees.
- One hard copy and an electronic copy of final report.

8. Qualification of the Consulting Firm and proposed Human Resource of the Organizations

The proponent should be Nepalese Organizations/Consulting Firms legally registered with sufficient relevant human resources, facilities and equipments required to accomplish the training and having experience in biogas training. In addition, the Organizations / Consulting Firms should be well known about prevailing policies and implementation modalities of AEPC and it should demonstrate its competency to carryout quality services.

The team should be composed of a Team Leader (Training Coordinator), qualified professionals (biogas trainers) to deliver theoretical and practical classes, Trainers should bequalified professionals with full experience in biogas training and a training assistant with full experience in biogas. They should have extensive knowledge and experience in the Domestic Biogas. Required human resource for each training as below details:

8.1 Team Leader/Training Coordinator - 1

Bachelors Degree in engineering with Biogas Level 4 passed from CTEVT and having at least 6 years of experiences in Biogas sector with extensive experience of already been resource person/training coordinator in biogas training. S/he should have thorough knowledge of the technical / managerial parameters, policies, procedures, guidelines and standards of biogas as well as quality assurance of the sector.

8.2 Trainers/Resource persons for theory and practical-2



Technical experts knowledgeable in design, installation and conducting training related to domestic biogas with bachelors degree in Engineering or level 4 passed from CTEVT with 3 years of experience in biogastraining works (practical and Theory). S/he should have thorough knowledge of the technical parameters, guidelines and standards of biogas as well as quality assurance of the sector.

8.3 Training Assistant - 1

A training assistant knowledgeable in design, installation and coordinating training related to domestic biogas with 3 years of experience in Biogas (Large or Domestic) Training. Technical/managerial parameters, policies, procedures, guidelines and standards of biogas as well as quality assurance of the sector.

9. Proposed Budget and Payment Schedule:

The total budget should be realistic and proposed by the firm in financial proposal for the project including all Taxes and VAT. In addition to the cost of experts, cost of technician, one field assistant and cost for local human resources and other cost such as cost for travel, import transportation cost, detail break down of activities should be clearly mentioned in the financial proposal. In the financial proposals, the consultant should not put any conditions.

accidents of all kinds, war to like conditions, riot, and civil commotion or due to circumstances beyond the control of consultant. Apart from an extension of the time of completion, force majeure does not entitle the consultant to any compensation for damage or loss suffered.

12. The Right to Audit:

The AEPC's Compliance Unit shall have the right to audit and inspect all books, records and underlying documentation relating or pertaining to contracts or agreements under AEPC, for delivery of goods or services, kept by or under the control of the Contractor including, but not limited to those kept by the Contractor and its employees, agents, assigns, successors and subcontractors.

The Contractor shall maintain such books and records, together with such supporting or underlying documents and materials, for the duration of the contract or agreement and at least to the end of the following Government of Nepal Fiscal Year from the approved date of the completion of the assignment as per contract or agreement with AEPC.

A clause regarding this facility will be included in the contract document.


