B. Background of the Program

Subsidy is a key financial intervention in the policy of Government of Nepal to promote rural and renewable technologies and is executed through AEPC. AEPC with support from various Donor Partners has been continuously working towards improving rural living standard through dissemination of Metallic Rocket Stove (ICS), MICS, Metallic Institutional Improved Cooking Stove & Thermal Gasifier. Government of Nepal has approved subsidy policy and subsidy delivery mechanism for implementation of subsidy programs.

As per the approved subsidy delivery mechanism 2073, subsidy for Metallic Rocket Stove (ICS), MICS, Metallic Institutional Improved Cooking stove & Thermal Gasifier can be implemented by reverse auctioning process and by demand driven model through recognized competent company/firm. Under second modality of demand driven model through recognized competent company/firm, the procurement of goods and services will be done by the households / Institution themselves. For this purpose AEPC intends to prepare list of recognized competent company/firm. The listed recognized competent company/firm will be responsible for design, supply, and installation and after sales service of Metallic Rocket Stove (ICS), MICS, Metallic Institutional Improved Cooking stove & Thermal Gasifier as per the requirement of following subsidy policy and subsidy delivery mechanism.

This recognized competent company/firm will be eligible for promotion and implementation of Metallic Rocket Stove (ICS), MICS, Metallic Institutional Improved Cook stove & Thermal Gasifier system listed below:

- 1. Metallic Rocket Stove (ICS)/Metallic Improved Cooking Stove (MICS)/Metallic Institutional Improved Cooking Stove (MIICS)**
- 2. Thermal Gasifier**

C. Criteria for Listing of Recognized Competent Company/Firm

Eligibility Criteria:

Company/Firm must be fulfilled the following Eligibility Criteria:

1. A Copy of Company/Firm Registration Certificate with updated renewed. The company/Firm must have experience of minimum three years.
2. A Copy of PAN or VAT Registration Certificate.
3. A Copy of Tax Clearance Certificate of F.Y. 2075/76.
4. Commitment letter from the company/firm mentioning that they will agree and work as per subsidy policy, subsidy delivery mechanism, technical standards, system configuration guideline and rules and regulation of AEPC.
5. A Copy of Memorandum of Association or Document demonstrating scope of work -Renewable Energy/Biomass Energy must be mentioned in document. In case of addition of renewable energy/Biomass energy in company/firm memorandum, the addition must be done at least three years before on the date of submission of application.
6. Self Declaration Letter along with the Application as per the attached format.
7. Company/Firm qualifying as Competent Company has to submit a Copy of Tax Clearance Certificate of F.Y. 2076/77 B.S. and Copy of Renewed Company/Firm Registration Certificate within 31 January 2021 A.D.

Note: Each Joint Venture (JV) partner(s) including lead partner must fulfill all the above Eligibility Criteria with JV agreement, in case of JV application submission.

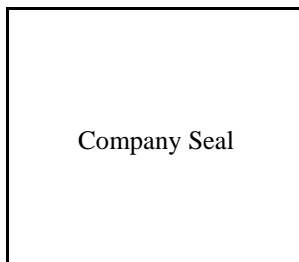
