1. **Alternative Energy Promotion Centre (AEPC)** invites **Electronic Bids** from eligible bidders for the “**Construction of Micro Hydro Projects at the following locations**” Bidding procedures as specified in prevailing Public Procurement Act and Public Procurement Regulations of Nepal. Bidding is open to all eligible bidders as per Section V of bidding document. Only eligible bidders with the following Key Qualifications should participate in this bidding:

2. Under the **Single Stage, Two Envelope Procedure**, Bidders are required to submit simultaneously **two separate sealed envelopes**, one containing **(i) the Technical Bid** and the other **(ii) the Price Bid**, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.

5. **Pre-Bid Meeting** shall be held at **AEPC, Mid-Baneshwor, Kathmandu** at **11:00 A.M. on 23 January 2022**.
6. Interested Eligible and Qualified Bidders are required to submit the Electronic Bids through e-GP system of PPMO **www.bolpatra.gov.np/egp** on or before **12:00 Noon on 06 February 2022**.
7. Submitted Electronic Bids will be opened in presence of Bidders' representatives who choose to attend at **12:15 P.M. on 06 February 2022** at the office of **AEPC, Mid-Baneshwor, Kathmandu, Nepal**. But nothing shall bar the opening of Bids by the reason only that any Bidder or its agent is not present. Bidder's representative should bear with authorization duly signed by the authority of firm at the time of Bid opening.
8. Bids must be valid for a period of 90 days counting from the day of bid opening and must be accompanied by scanned copy of the bid security in PDF format, amounting to a minimum of **NRs. 700,000.00** (In Words: Seven Hundred Thousand Rupees Only) which shall be valid for minimum 30 days beyond the bid validity period (i.e., Valid up to minimum 05 June 2022).

9. If bidder wishes to submit the Bid Security in the form of cash, the cash should be deposited in Office Code: **3080002** and Account Name: **DTCO, Kathmandu**, Bank Account No.: **1201200001002524** at Nepal Rastra Bank, Thapathali and submit/upload the receipt of the deposited amount of cash along with the eBid.
