- The AEPCC invites **Electronic Bids** from eligible bidders for the procurement of goods "Supply, Delivery and Installation of Solar Home System (SHS) for Targeted Group under Clean Energy Programme" under National Competitive Bidding (NCB) procedures specified in Public Procurement Act and Regulations. Bidding is open to all eligible and qualified Bidders/Suppliers.

- Pre-bid meeting shall be held at AEPCC, Khumaltar Height, Lalitpur, Nepal at 11.00 A.M. on 17 December 2018.
- Interested Bidders shall submit the Electronic Bids through www.bolpatra.gov.np/egp to the above office of AEPCC on or before **12:00 Noon on 3 January 2019**.
- Submitted Bids shall be opened in presence of Bidders' representatives who choose to attend on **12:30 P.M. on 3 January 2019** at the office of AEPCC, Khumaltar Height Lalitpur. But nothing shall bar the opening of Tender by the reason only that any bidder or its agent is not present. Bidder's representative should bear the authorization letter duly signed by the authority of firm at the time of bid opening.
- Bids must be valid for a period of 90 days counting from the date of bid opening and must be accompanied by the bid security (Bank Guarantee or Cash Deposited into Bank) amounting to minimum of NRs. as per table given below:

- The bidders are eligible to bid for any single or multiple or all the packages. Bid security amount and other criteria should be submitted/fulfilled as per bided package(s).
- If bidder wishes to submit the Bid Security in the form of cash, the cash should be deposited in AEPCC's Office Code 28-331-01 and Account Name DTCO, Lalitpur, Bank Account No. 16856 KHA 3 at Nepal Bank Ltd., Gabahal, Lalitpur Branch and submit the original receipt of the deposited amount of cash along with the Bid.
- If the last date of purchasing and/or submission falls on a government/public holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
- Bidders are advised to visit site and assess the actual site conditions before submitting their bid. AEPCC shall not be responsible for any costs or expenses incurred by bidders in connection with preparation or submission of Bids.
