1. AEPC has received Funds from the Government of Nepal (GoN) towards the cost of *Terai Clean Cooking Program* and intends to apply part of the funds to cover eligible payments under the Contract.
2. The AEPC invites **Electronic Bids** from eligible bidders for the procurement of goods *Supply, Delivery and Installation of Induction Cookstoves along with housewiring upgradation in households of partner Local Governments in Terai region (Package II)* under National Competitive Bidding (NCB) procedures specified in Public Procurement Act and Regulations. Bidding is open to all eligible and qualified Bidders/Suppliers.

5. Pre-bid meeting shall be held at AEPC, Mid Baneshwor, Kathmandu Nepal at **11.00 A.M. on 05 April 2020**.
6. Interested Bidders shall submit the Electronic Bids through www.bolpatra.gov.np/egg to the above office of AEPC on or before **12:00 Noon on 19 April 2020**.
7. Submitted Bids shall be opened in presence of Bidders' representatives who choose to attend on **12:20 P.M. on 19 April 2020** at the office of AEPC, Mid Baneshwor, Kathmandu Nepal. But nothing shall bar the opening of Tender by the reason only that any bidder or its agent is not present. Bidder's representative should bear the authorization letter duly signed by the authority of firm at the time of bid opening.
8. Bids must be valid for a period of 90 days counting from the day of bid opening and must be accompanied by bid security, amounting to a minimum of **NRs. 800,000.00** which shall be valid for minimum 30 days beyond the bid validity period (i.e., **Valid up to minimum 16 August 2020**).
